Alden	Chris	Chris Alden is Professor in International Relations at the London School of Economics and Political Science (LSE) and Director of LSE IDEAS. He is author or editor of <i>New Directions in Africa-China Studies</i> (Routledge 2018), <i>China and Africa – Building Peace and Security Cooperation on the Continent</i> (Palgrave 2017), <i>China and Mozambique: From Comrades to Capitalist</i> (Johannesburg: Jacana 2014), <i>Returns to Africa</i> (Hurst 2008), <i>China in Africa</i> (Zed 2007). He regularly teaches courses at University of Cape Town and Peking University and was a Senior Lecturer in International Relations at the University of the Witwatersrand, 1990-2000.

He has researched, taught and published widely in the areas of policing, criminal justice, drug policy and control, security governance and organised crime. He has also served as a member of several federal government committees and commissions established for the reform of security and law enforcement systems in Nigeria. Prof Alemika was consultant on police, policing, drug policy and control, governance and corruption, elections, security reform and governance for several national and international organisations.
